Grant and Revolving Loan Fund Program- A presentation was given by Niki Vanderslice and following an extensive discussion Mayor Edward Johnson made a motion to approve the Grant and Revolving Loan Fund Program as a pilot initiative, reflecting FCDA's commitment to careful and strategic implementation. The program would allocate an initial funding of up to 7.7 million dollars, which will be divided between the grant and revolving loan components. Dr. Luis Matta seconded the motion. All were in favor.

Niki Vanderslice shared the film update provided by Melissa Hill and reported that FCDA is contracting Boyette Strategic Advisors for a film impact study- cost 20K.
